

# Terms & Conditions for app.o-sign.eu

Last updated: 31 May 2025

## 1. SUBJECT MATTER AND SCOPE

1.1. These Terms & Conditions govern:

- Use of the Platform by clubs, volunteers, and runners;
- Registration and participation in events;
- Data protection and privacy rules;
- Liability limitations;
- Special provisions for minors.

1.2. The app.o-sign.eu platform (“Platform”) is an electronic registration and event management system created, owned, and operated by Mentor Silva Club, here after named Platform Administrator.

1.3. The platform is created within the European project 101184505 — O SIGN — ERASMUS-SPORT-2024— and it is used by the following Partner Clubs: Mentor Silva Club, AOK Košutnjak, Magnets, Nirvana Verde and WKS Wawel

1.4. The Platform facilitates online registration of individuals as runners or volunteers for sport events organized by Partner Clubs.

1.5. Each Partner Club has administrative rights only for their own events and is responsible for managing their own event registrations, communication with participants, and event-specific terms.

1.6. Accessing or using the Platform signifies unconditional acceptance of these Terms & Conditions.

## 2. ACCESS TO THE PLATFORM

2.1. Partner Clubs receive approval for own events creation and administration rights from the Platform Administrator, by appointing one club administrator and sending to the Platform Administrator the necessary contact details.



2.2. Partner Clubs have administration rights only for their own events. Each Partner Club manages participant lists, communicates directly and is responsible for the participants in own events.

2.3. Access to public parts of the Platform is open to all users. Registration for events requires an account and completion of the event registration form.

2.4 Users must provide accurate and complete information; false or incomplete data may lead to cancellation of registration.

### **3. USING THE PLATFORM**

3.1 Users warrant that they will use the Platform in accordance with these Terms & Conditions, applicable laws, and in a responsible manner.

3.2 Participants may register as: (a) Runner – a participant in the sporting event; (b) Volunteer – a person assisting in the organization of the event.

3.3. Roles are selected during registration and may be subject to verification by the event organizer.

### **4. EVENT RULES AND CONDUCT**

4.1. By registering, participants agree to abide by the specific rules and regulations of the event they attend.

4.2. The Partner Clubs reserve the right to disqualify or remove any participant from an event for:

- Dangerous or unsportsmanlike conduct;
- Failure to follow instructions;
- Use of prohibited substances or items.

4.3. Decisions by event officials are final.

### **5. PARTICIPATION OF MINORS**

5.1. A “Minor” is any participant under the age of 18.

5.2. Minors **may only register and participate with the explicit consent** of a parent or legal guardian.

5.3. The parent/legal guardian assumes full legal and financial responsibility for Minor's registration as user in the Platform, as well as for Minor's participation in sport events, including health, safety, and conduct during the sport events.

5.4. The organizing Partner Club reserves the right to request proof of age and proof of explicit guardian consent at any time.

## **6. RISK, LIABILITY AND INSURANCE**

6.1 By registering for an event, the participant declares that they have no medical contraindications for participation and that they take part entirely at their own risk.

6.2 The participant hereby acknowledges that sports events involve physical effort and carry inherent hazards and natural risks of accidents, including injuries, ranging from minor to extremely severe endangering life ones, as well as property damage. By registering, participants (or their guardians, in the case of Minors) accept these risks.

6.3 Organizers do not insure participants against accidents or loss. Participants are advised to arrange their own insurance coverage.

6.4. The organizers are not responsible for personal belongings lost, damaged, or left unattended during the event.

6.5. In case of accident or illness during the event, the organizers may provide first aid, but do not assume further responsibility.

## **7. DATA PROTECTION AND PRIVACY**

7.1. Personal data collected through the Platform will be used only for purposes related to event administration, communication, and promotion, in compliance with applicable data protection laws, including GDPR.

7.2. By registering, the participant consents to the inclusion of their name in start lists and race results, and to the use of their image (in photos and videos from the event) in informational, marketing, and promotional materials of the Partner Clubs.

7.3. Data may be shared with third parties involved in event organization under appropriate data processing agreements.

7.4. Each Partner Club is responsible for data related to its own events.

7.5. Providing personal data is voluntary but necessary to participate; participants have the right to access and request correction of their personal data.

## 8. INTELLECTUAL PROPERTY

8.1 All materials, logos, and software associated with the Platform are the intellectual property of Mentor Silva Club or the respective Partner Club.

8.2 Users may not copy, distribute, or modify content without prior written consent.

## 9. MODIFICATIONS TO TERMS

9.1 Mentor Silva Club and Partner Clubs may amend these Terms & Conditions at any time. The latest version will be available on the Platform.

9.2 Continued use of the Platform constitutes acceptance of the updated Terms & Conditions.

## 10. GOVERNING LAW AND DISPUTE RESOLUTION

10.1 These Terms & Conditions are governed by the laws of the country in which the organizing Partner Club is established.

10.2 Any disputes will be subject to the jurisdiction of the competent courts in that country.
